Guide of services provided by the Border Police at the crossing point Pervomaisc - Cuciurgan

Border Police of the Republic of Moldova provides the following services:

-  1. Registration of the crossings of foreign citizens in the Information System;
-  2. Consultation of the persons regarding the crossing rules of the state border;
-  3. Issuance for foreigners Moldovan visas at the state border, in exceptional cases;
-  4. Receiving the asylum applications at the state border.

Registration of the crossings of foreign citizens in the Information System

✓ *Who will benefit from this service?*

- Any foreign citizen who legally crosses the state border of the Republic of Moldova.

- Persons who are residents of the cities/villages from the left bank of the Dniester (Transdnistria), do not need registration, as they are, according to the law, exempted from the liability if they do not declare their entry, within the period stipulated by the law, to the competent authorities on the territory of the Republic of Moldova.

✓ *What are the advantages of registration of foreign citizens in the Information System?*

- The foreign citizen will obtain the possibility to legalize his/her entry or exit into / from the Republic of Moldova, to the official authority of the Republic of Moldova in the easiest way, directly at the crossing point;

- The foreign citizen, who entered the Republic of Moldova through the Transdnistrian region of the state border, is automatically exempted from the obligation to declare personally about the entry, within 72 hours from the crossing of the state border of the Republic of Moldova, in order to be taken to evidence, to one of the following structures:

- 1) any subdivision of the Migration and Asylum Bureau;
- 2) any border crossing point in which the border policemen work;
- 3) subdivisions of State Enterprise "CRIS" Registru ".

- Immediately on the next trip, the foreign citizen will not risk to be penalized for illegal entry and stay within the country;

- Regarding the foreign citizen, and the means of transport with which he/she crossed the border, there will be formed a history of the crossings, and subsequently, he/she may request and obtain the official information from the Border Police on personal crossings.

✓ *How can the foreign citizens obtain the registration service in the Information System?*

- The foreign citizen, during the control procedure at the state border crossing point, may declare, to the control authorities of the Republic of Moldova or Ukraine, his intention to obtain the registration service. As a result, the foreign citizen will be directed to the representative of the Border Police of the Republic of Moldova.

Consultation of the persons regarding the crossing rules of the state border

✓ *Who will benefit from the given service?*

- Any person who crosses the state border can obtain a qualitative consultation on the rules of crossing the state border by persons, including minors, as well as with regard to the means of transportation; The requirements established concerning the necessary documents for the crossing of the state border; Conditions of entry / stay and exit of foreign citizens, and means of transportation in / from the territory of the Republic of Moldova.

✓ *What are the benefits of the consultation service?*

- The service will be directly provided, at the crossing point, by communicating with a specialist in the field. Therefore, the benefit consists in providing legal support to the persons in order to clarify the legal possibilities for entering / exiting / transiting in / through / from the territory of the Republic of Moldova.

✓ *How can the persons receive the consultation service?*

During the control procedure at the crossing point, the person can directly request and obtain the consultation service by requesting assistance of the representative of the Border Police of the Republic of Moldova.

Issuance to foreigners the Moldovan visas at the state border, in exceptional cases

✓ *Who will benefit from this service?*

The citizens of the states with whom the Republic of Moldova has a visa regime, can receive short-term visas for entry and stay on the territory of the Republic of Moldova, under the following conditions:

- in case of emergency, caused by disasters, natural calamities or accidents;
- in case of death or serious illness of a relative located on the territory of the Republic of Moldova, confirmed by a document issued by the competent authorities;
- in emergency situations, when crews and passengers of the ships or aircrafts are obliged to land or to moor, in the case of malfunction, bad weather conditions or threat of a terrorist attack;
- in the case of the officials of international organizations or delegates who carry out official missions to the Republic of Moldova, within a short time frame that will not exceed 15 calendar days;
- in the case of participants who take part in international actions, which are organized in the Republic of Moldova with the consent of the Ministry of Foreign Affairs and European Integration, if the period of time between the date of the information of the participants and the date of the actions does not allow to obtain the visas.

✓ *What are the advantages of obtaining a visa in exceptional circumstances?*

- The foreign citizen can obtain the visa to entry on the territory of the Republic of Moldova, in exceptional given situations, at the official authority of the Republic of Moldova, directly at the crossing point, in the shortest and easiest way.

How can the foreign citizen, in exceptional situations, obtain the visa of the Republic of Moldova?

The foreign citizen, being in an exceptional situation mentioned above, may request the issuance of the visa for entry on the territory of the Republic of Moldova, by directly requesting the assistance of the representative of the Border Police of the Republic of Moldova.

As a result of the examination of the exceptional situation and its confirmatory documents, the representative of the Border Police will issue, in the exceptional situation, the visa of the Republic of Moldova.

Receiving asylum applications at the state border

✓ *Who will benefit from this service?*

- Asylum-seekers may be foreign citizens or stateless persons who are in a situation where their life or health is actually jeopardized, and the foreigner cannot or does not want to obtain protection from the country of origin.

✓ *What are the benefits of this service?*

- The foreign citizen can submit the asylum application to the official authority of the Republic of Moldova, at the state border crossing point, in a short time and the easiest way.

✓ *How can a foreigner submit a request of asylum?*

- The asylum application is directly and personally submitted by the foreigner at the border crossing point, to the representative of the Border Police of the Republic of Moldova
